CITY COUNCIL PROCEEDINGS
10/04/2021

The Onida City Council met on Monday, October 4th, 2021 at 7:30 p.m. in the City Office with Mayor LaJena Gruis presiding. Present at Roll Call: Brooke Jacquot, Marla Mosiman, Jessica Olivier, Jane Pitlick and Caleb Shepherd. Also present: Tim Jost, Casey Hight, Sheila Ring, and Charles Trumble.

PLEDGE OF ALLEGIANCE: Mayor Gruis opened the meeting with the Pledge of Allegiance.

MINUTES: Motion by Pitlick seconded by Jacquot to approve the minutes from the September 7th and 27th, 2021 City Council meetings. All ayes. Motion carried.

REPORTS: Jost reported that MC & R Pools will be here October 7th to winterize the splash park, the street light problem on the west side of the city has been diagnosed with the part being ordered which is two weeks out. Jost also stated that he and Jeff had gone to Chamberlain for training. The cleanup process around the city shop is going well, Matt Horman plans on being here to clean up the landfill after harvest is complete. Jost has also been in contact with Dakota Pump regarding the lift station. He informed council that we could sign up for a yearly inspection with Dakota Pump at a price of \$450 per year. Council advised Jost to get signed up for this. Jost also advised Council on a side dump that he would like to purchase to use on the garbage truck which would aid them in snow removal. The price for said trailer is \$1000 a foot. Motion by Shepherd seconded by Jacquot to approve the purchase. Roll Call: All ayes. Motion carried. Absent: Mennenger. A proposal of \$9602.06 for a shop door in the new shop was received from Overhead Door. Motion by Shepherd seconded by Olivier to approve this purchase. Roll Call: All ayes. Motion carried. Absent: Mennenger.

SHERIFFS REPORT: Deputy Hight stated that law enforcement had been called out to a domestic disturbance and a shooting incident in which no one was hurt but charges have been filed. He also stated that they have been busy with traffic control especially for those that feel the need to make black marks on the new streets.

AIRPORT: Charles Trumble was present to discuss the rental spot he has in the new revenue producing hangar. He explained to the Council that he had not been in the hangar the first three months and did feel he should have to pay for a whole year's rental on said hangar being that it was newly built. The contract that he needs to sign states that there will be no pro-rating on the contract price but Council did advise Mr. Trumble that they would take exception with this since it is special circumstances and pro-rate his rate for three quarters of a year. Motion by Pitlick seconded by Shepherd. All ayes. Motion carried.

LEGALS: The second reading to ordinance 2021-1005 was completed with motion by Pitlick seconded by Olivier to approve the ordinance. Roll Call: All ayes. Motion carried. Absent: Mennenger. The first reading of ordinance 2021-1004 was completed with advice from Sovell to strike one statement. Motion by Shepherd seconded by Mosiman to approve the deletion. All ayes. Motion carried.

SPECIAL ALCOHOL REQUEST: A request from the Onida Fire Department was received to allow them to serve alcohol during the Annual roast Beef Supper and Fun night on October 16th. Motion

by Pitlick seconded by Jacquot to approve the request. Roll Call: All ayes. Motion carried. Absent: Mennenger.

BANKWEST: A request was received from BankWest that they be allowed, in the event of an emergency, to use the Phoenix Center as a place of business. Council advised Hiller that they have no problems with this and advised Hiller to make sure that BankWest understands that they will be charged the normal rental fee for use of the center.
