## APPROVED CITY COUNCIL PROCEEDINGS 01/03/2022

The Onida City Council met on Monday, January 3<sup>rd</sup>, 2022 at 7:30 p.m. at the City Office with Mayor LaJena Gruis presiding. Following the Pledge of Allegiance was roll call. Present at Roll Call: Brooke Jacquot, Justin Mennenger, Marla Mosiman, and Jessica Olivier. Also present, Tim Jost, Casey Hight, and Sheila Ring.

**MINUTES:** Motion by Jacquot seconded by Mosiman to approve the minutes from the December 6<sup>th</sup> and 28<sup>th</sup>, 2021 City Council meetings. All ayes. Motion carried.

**REPORTS:** Jost inquired about having 18 blocks of streets chip sealed this summer in which council advised him to put the details together so that we can get it out for bids, tires have been purchased for the garbage truck through surplus out of Huron but there were not enough tires for the truck so he has been in contact with Jeff Lamb about purchasing the remaining needed tires, 1 load of furniture has been taken to the Pierre landfill, and he updated the council on the water leak in the area of the 400 block of 6<sup>th</sup> Street. Initially, the leak was thought to be in the street at 405 South 6<sup>th</sup> Street but when the area was dug up there was no leak. The technician from SDARWS did some more searching and found the leak on the property of 403 South 6<sup>th</sup> Street. Water has been shut off at the curb stop and the property owners, who are seasonal users, will be notified.

**Sherriff Dept.:** Deputy Hight stated that a joint warrant was executed for an individual on December 23<sup>rd</sup>. Other than that, December had been a quiet month.

**LAW ENFORCEMENT CONTRACT:** Hiller presented to Council the new Law Enforcement Contract for 2022 which includes a 3% increase. Motion by Olivier seconded by Mennenger to approve the contract. Roll Call: All ayes. Motion carried. Absent: Pitlick and Shepherd.

The election will be held on April 12<sup>th</sup>, 2022. Circulation of nominating petitions may begin on January 28<sup>th</sup>, 2022 and petitions may be filed in the office of the finance officer located at 117 South Main Street between the hours of 8:00 a.m. and 5:00 p.m., central time not later than the 25th day of February, 2022, or mailed by registered mail not later than the 25<sup>th</sup> day of February, 2022, by 5:00 p.m. central time.

**BUILDING PERMITS:** The following building permit was received for approval:

ANNUAL REPORT AND AUDIT PROPOSALS: Proposals were received from Kohlman, Bierschbach & Anderson regarding helping Hiller with the annual report, not to exceed \$615.00, and the two-year audit for 2020 and 2021 which will not exceed \$13,000 or \$16,500 dependent upon how much federal monies were received for projects. Motion by Mosiman seconded by Jacquot to approve the proposals. Roll Call: All ayes. Motion carried. Absent: Pitlick and Shepherd.

**EXECUTIVE SESSION**: Motion by Jacquot seconded by Mosiman to go into Executive Session at 7:55 p.m. pursuant to SDCL 1-25-2(1). All ayes. Motion carried. Motion by Jacquot seconded by Mosiman to come out of Executive Session at 8:25 p.m. All ayes. Motion carried.
