APPROVED CITY COUNCIL PROCEEDINGS 02-05-2024

The Onida City Council met on Monday, February 5th, 2024 at 6:30 p.m. at the City Office with Mayor LaJena Gruis presiding. Present at Roll Call: Brooke Jacquot, Casey Clark, Marla Mosiman, Jessica Olivier, and Caleb Shepherd. Also present: Bill Stahl, Austin Gross, and Sheila Ring. Clark Jordre arrived at 6:32 p.m.

PLEDGE OF ALLEGIANCE: Gruis opened the meeting with the Pledge of Allegiance.

MINUTES: Motion by Mosiman seconded by Jaquot to approve the minutes from the January 2nd, and January 16th, 2024 City Council meetings. All ayes. Motion carried.

REPORTS: Superintendent Gruis left a copy of his reports as he and Volker were in Sioux Falls attending wastewater classes. The report stated that they spent January moving snow, receiving a 2018 Ford f150, discovered damage to gopher gulch, and made equipment and maintenance repairs. Gruis also stated that her would like to have load limits applied to city streets. Council discussed the load limit request and the areas that Gruis was wanting to post. Signs have been ordered and will be placed appropriately upon their arrival. Hiller advised council that she and Gruis had made the decision to order a confined space rescue system with Hiller stating that she had been in contact with Insurance Benefits/SDML Workers Comp and found that they had a grant for this purchase in which we would be reimbursed for 50% of the purchase price but we had a limited time to make the purchase as grant monies were almost gone. Hiller stated that this purchase was accepted and she has completed the paperwork to receive our grant money.

Sherriff Dept.: Stahl reported that he has had a lot of reports of phone and computer scams.

AUSTIN GROSS/BAD CHICKEN: Austin Gross was present to discuss with council his option of requesting a condition use permit for property located at 705 Birch Avenue. Mr. Gross would like to make living quarters to be used for his farm workers. Hiller provided council a copy of an amendment to Onida zoning ordinances which was completed in 2017. Council could find no problems with Gross's request but did make some suggestions that Mr. Gross stated he had no problems with. Hiller will give Mr. Gross his needed documents and make publications and mail notifications to those within the area. The hearing will be at the March 4th, 2024 city council meeting.
